The LDMCR is installed in A330-900 series aircraft per Drawing List Lower Deck Mobile Crew Rest TTF-DL-17T006-2, Revision C, dated July 19, 2019, contained in Master Data List TTF-MDL-17T006-1, Revision B, dated August 7, 2019, or later FAA-approved revisions.

The LDMCR is eligible for installation only on those Manufacturer Serial Numbers (MSN) effectivities listed in Master Data List TTF-MDL-17T006-1, Revision B, dated August 7, 2019, or later FAA-approved revision.

If the holder agrees to permit another person to use this certificate to alter the product, the holder shall give the other person written evidence of that permission.

## Certification Basis:

The certification basis for the changed Airbus Model A330-300 and A330-900 Series aircraft as described in this certificate is as follows:

- a. The type certification basis for the Airbus Model A330-300 and A330-900 Series aircraft is shown on TCDS A46NM for parts not changed or not affected by this change.
- b. The certification basis for the parts changed or affected by this change since the reference date of application, June 25, 2019, is shown on TCDS A46NM.
